When the End Comes to Higher Education Institutions, 1890-2019: A Data Source Virginia Sapiro Boston University

This is a partial list of the concluding episodes of the independent existence of a selection of higher education institutions from 1890 to the beginning of 2019. It aims to include all institutions that were ever regionally accredited at the bachelors level or above or whose resources contributed in a genealogical sense to an institution that was accredited at that level. Or the era before accreditation it includes all institutions that were authorized to confer bachelors degrees or above or that contributed in a genealogical sense to an institution so authorized. It excludes straightforward transformations of an institution, as when an academy or normal school is re-chartered to become a college or university. It excludes for-profit institutions because their lives and deaths are very different given that they are treated as commodities with the primary purpose of revenue enhancement for owners.

This listing shows different kinds of finality. These include:

- The institution simply closes. In some cases the assets are acquired by another or successor institution of higher education, which may acknowledge the closed institution, for example, by naming a program after it, but the closed institution no longer has an independent existence.
- One institution merges into another. Even if its name is preserved, for example, as the name of a college in a university, it no longer has separate accreditation or autonomy.
- A new higher education institution is created by the merging of previously existing institutions.

This list is arranged by year and then by alphabetical order of the latest state in which the institution or its successor existed. It uses the contemporaneous names of the institution. Parenthesized institutional names indicate the final name of the institution if different from the contemporaneous name. Each listing includes a parenthesized indication of the state in which the final institution is or was located.

This list is culled from a much large *Timeline and Genealogy of Higher Education in the United States* compiled by the author.

1890

- The Chicago College of Dental Surgery (Loyola University of Chicago) is merged into Lake Forest University (Lake Forest College) as its Dental Department. The affiliation ends in 1902. (IL)
- Taylor University is founded by merging Fort Wayne College and Fort Wayne College of Medicine. (IN)
- The Omaha Medical College merges into the University of Omaha. (University of Nebraska Medical Center, NE)

- o The Union College of Law merges into Northwestern University. (IL)
- St. Louis Medical College merges into Washington University. (University of Washington in St. Louis, MO)
- The Rochester Athenaeum and Mechanics Institute is founded by merging the Rochester Athenaeum and Mechanics' Association and the Mechanics Institute. (Rochester Institute of Technology, NY)

- Ohio Central College faces financial collapse and closes. The state of Ohio purchases the property and makes it a "Working Home for the Blind." (OH)
- Palatinate College closes due to financial problems and is purchased by the United Evangelical Church, which transforms it into the Albright Collegiate Institute. (Albright College, PA)

1895

 Milwaukee-Downer College is created by merging Milwaukee College and Downer College. (Lawrence University, WI)

1896

- o When Berkeley Bible Seminary is founded, Hesperian College and Pierce Bible College are merged into it. (Chapman University, CA)
- o Napa College merges into California Wesleyan College. (College of the Pacific, CA)
- Mary Sharp College closes, unable to withstand the economic challenges that began with its physical destruction during the Civil War and increased during the financial depression of the early 1890s. (TN)

1897

- Hartsville College closes after years of financial problems and severe conflict between different factions of the United Brethren. Its assets are transferred to the newly established Central College. (Huntington University, IN)
- o Shepardson College for Women merges into Denison University. (OH)
- The Cincinnati Law School and Cincinnati College are merged into the University of Cincinnati. (OH)

1898

 The Boston Normal School of Cookery merges into the Framingham State Normal School and becomes its Household Arts Department. (Framingham State University, MA)

1899

- Elk Horn College merges with Trinitatis Seminarium (Trinity Seminary), becomes coeducational, and is renamed Trinity Seminary and Blair College, still using Danish as the official language. (Dana College, Closed, NE)
- The North Pacific Dental College is created by merging the Tacoma College of Dental Surgery and the Oregon College of Dentistry. (Oregon Health and Science University, OR)
- Virginia Union University is created by the American Baptist Home Mission Society by merging Wayland Seminary and Richmond Theological Seminar. (VA)

1900

Maclay College of Theology merges into the University of Southern California.
 (Claremont College of Theology, CA)

1901

 Eastern Indiana Normal School closes for lack of funds. It reopens in 1902 as Palmer University in honor of a donor who funds it. (Ball State University, IN)

- Danville Theological Seminary merges into Louisville Presbyterian Seminary. Danville had suffered a severe enrollment decline during the Civil War and never recovered. (Louisville Presbyterian Theological Seminary, KY)
- o Central University at Richman is merged into Centre College. (KY)

- The Omaha Medical College merges into the University of Nebraska and is renamed the University of Nebraska College of Medicine. (University of Nebraska Medical Center, NE)
- o Central Pennsylvania College merges into Albright College. (PA)

1903

o Marion-Sims-Beaumont College of Medicine merges into Saint Louis University. (MO)

1904

 The Chicago School of Osteopathy merges into the American College of Osteopathic Medicine and Surgery. (IL)

1905

- Central College of Physicians and Surgeons merges with Fort Wayne College of Medicine and Medical College of Indiana into Purdue University to form its Medical College in the School of Medicine. (Indiana University-Purdue University Indianapolis, IN)
- The Northern Indiana Law School merges into Valparaiso University as the Valparaiso University Law School. (Closed, IN)
- Red River Valley University, facing financial challenges, merges into the University of North Dakota. (ND)

1906

 Indiana Normal College closes because of a lack of enrollment and funds. The facilities are not used until 1912, when investors reopen the institution as Indiana Normal Institute. (Ball State University, IN)

1907 The Panic of 1907

- State College of Physicians and Surgeons in Indianapolis merges into Indiana University School of Medicine. (Indiana University-Purdue University Indianapolis)
- The Milwaukee Medical College merges into Marquette College, which is renamed Marquette University. (WI)

- Cooper Medical College merges into Stanford University as its Department of Medicine.
 (CA)
- Scarritt-Morrisville College is founded by the Methodist Episcopal Church South by merging Scarritt Collegiate Institute and Morrisville College. (Central Methodist University, MO)
- The Washington College Academy merges with Greenville and Tusculum College and is renamed Washington and Tusculum College. The trustees of Washington College successfully sue to break the merger in 1912 and it becomes independent again. Washington and Tusculum College is renamed Tusculum College. (TN)

- The Los Angeles Optical College and Post Graduate School of Opticians affiliates with the Southern California Eye College to create the California College of Optometry and Opthalmology. (Marshall B. Ketchum University, CA).
- o The Boston Normal School of Gymnastics merges into Wellesley College as its Department of Hygiene and Physical Education. (Wellesley College, MA)
- 1910 The Flexner Report criticizes the state of contemporary medical education
 - South Mississippi College is destroyed by fire and closes. (William Carey College, MS)

1911

- O St. Vincent's College closes when the Jesuits move into higher education in the region and the Vincentians focus on other things. (CA)
- Immaculate Conception College and Loyola College merge and reorganize. Immaculate Conception becomes the preparatory academy and Loyola remains the college. (Loyola University New Orleans, LA)
- o Scio University merges into Mount Union College. (University of Mount Union, OH)
- The University of Tennessee, Memphis is founded by merging together the Memphis Hospital Medical College, the College of Physicians and Surgeons, the Nashville Medical College, the Medical Department of the University of Tennessee, and Lincoln Memorial University. This action is motivated by the recommendations of the 1910 Flexner Report on the quality of medical education in the U.S. (University of Tennessee Health Science Center, TN)
- Financial difficulties and disagreements between the Oklahoma conferences of the Methodist Episcopal Church and the Methodist Episcopal Church South lead to the closing of Epworth University. The Oklahoma Conference of the Methodist Episcopal Church transfers its support to a new Methodist University of Oklahoma. It opens with faculty from Epworth University and Fort Worth University. (Oklahoma City University, OK)
- Although Fort Worth University has bachelors degree programs, an academy, a law school, medical school, school of pharmacy, conservatory of music, and other schools.
 The Methodist conference decides to close the university and merge it into the Methodist University of Oklahoma. (Oklahoma City University, OK)

1912

- The Denver and Gross Colleges of Medicine in Denver merge into the University of Colorado. (CO)
- o Keachie Female College closes due to financial problems. (Louisiana College, LA)

- The College of Medicine, Dentistry, and Pharmacy is created by merging The Chicago College of Pharmacy, the College of Physicians, and the Columbian College of Dentistry (University of Illinois Chicago, IL)
- o The Williamsburg Institute acquires Highland College and is renamed Cumberland College. (University of the Cumberlands, KY)
- The Baltimore Medical College merges into the University of Maryland. (University of Maryland, Baltimore, MD)
- o Baldwin-Wallace College is founded through the merging of German Wallace College and Baldwin University. (Baldwin Wallace University, OH)
- The Oregon Peerless College of Chiropractic-Neuropathy merges into The Pacific College of Chiropractic because it is no longer financially viable. (University of Western

- States, OR)
- Ward-Belmont College, a junior college and preparatory school is created by merging together the Belmont College for Young Women and the Ward Seminary for Young Ladies. (Belmont University, TN)
- Marquette University acquires the Wisconsin College of Physicians and Surgeons, creating the Marquette University School of Medicine. (Medical College of Wisconsin, WI)

- The College of Osteopathic Physicians and Surgeons is created by merging the Pacific College of Osteopathy with the Los Angeles College of Osteopathy. (UC Irvine Health School of Medicine, CA).
- The Benjamin Harrison Law School, an evening law school, is created by merging the Indianapolis College of Law with the American Central Law School. (Indiana University Purdue University Indianapolis, IN)

1915

Following the critical review by the Flexner Report, enrollment at the College of Physicians and Surgeons declines steeply and it is merged with the Medical College of the University of Maryland. (University of Maryland, Baltimore, MD)

1916

- College of Montana, which has been struggling financially, closes. In 1923 its organization is merged with Montana Wesleyan College. (Rocky Mountain College, MT)
- York College acquires York Business College. (NE)
- Des Moines College (IA) acquires the Central College of Pella (IA) and then in 1918 Highland Park College (IA), and is renamed Des Moines University. (University of Sioux Falls, SD)

1917 U.S. enters WWI

- o Indiana Normal Institute closes because of foreclosure on its mortgage payments. (Ball State University, IN)
- Eastern University Preparatory School closes, but in 1919 it is re-founded as Oklahoma Military Academy. (Rogers State University, OK)

1918 End of WWI

- Southern College and Birmingham College are merged to form Birmingham-Southern College on the Birmingham campus, a Methodist college. (GA)
- Marion Normal Institute relocates to Muncie Indiana and merges with the Indiana Normal Institute (Ball State University). The union, and with it Marion Normal Institute, fail. The Wesleyan Methodists buy its assets and merge them with the Fairmount Bible College and opened the new institution as Marion College in 1919. It opens in 1920. The first class graduates with bachelor's degrees in 1921. A master's degree is launched in 1924. (Indiana Wesleyan University, IN)
- Saint Peter's College closes during WWI so the Jesuits could focus on other campuses.
 It reopens in 1930. (Saint Peter's University, NJ)
- The Dorland Institute merges with the Bell Institute to form the coeducational Dorland-Bell School. (Warren Wilson College, NC)
- o Cincinnati College is merged into the University of Cincinnati. (OH)
- Lutheran Normal School merges with Augustana College under the name Augustana College and Normal School. (Augustana University, SD)

o Texas Christian University closes. (TX)

1919

- Leander Clark College becomes bankrupt and merges with Coe College. Despite this new infusion of some assets, Coe College regularly operates on a deficit. (IA)
- New Orleans College of Pharmacy merges into Loyola University. The Pharmacy school is discontinued in 1965. (Loyola University New Orleans)
- The Kansas City Western Dental College, founded by merging Kansas City Dental College and the Western Dental College. (University of Missouri-Kansas City, MO)
- o Roper Hospital School of Nursing merges into the Medical College of the State of South Carolina. (Medical University of South Carolina, SC)
- Methodist University of Oklahoma faces severe enrollment and therefore financial challenges due to World War I and the influenza epidemic. The Methodist Episcopal Conference closes it and opens a new college in a new location, Oklahoma City College. (Oklahoma City University, OK)

1920 *The Depression of 1920-21*

- The California School of Christianity, founded by merging the Berkeley Bible Seminary and the California Christian College. (Chapman University, CA)
- The University of Maryland, created by merging the Maryland State College of Agriculture and the University of Maryland in Baltimore. (University of Maryland, College Park, MD)
- Bethany-Peniel College is created by merging Peniel College with Oklahoma Nazarene College. (Southern Nazarene University, OK)

1921

- The University of Delaware is created by merging Delaware College with the Women's College of Delaware. (DE)
- O North Pacific College of Optometry, founded by merging the DeKeyser Institute of Optometry and the Oregon College of Ocular Science. (Pacific University, OR)

1922

- The Los Angeles College of Chiropractic absorbs the Eclectic College of Chiropractic.
 (Southern California University of Health Sciences, CA)
- Sacred Heart College, a women's college created by the Dominican Sisters of Grand Rapids, and merged with the Novitiate Normal School. It is chartered to grant degrees in 1923. (Aquinas College, MI)
- Central College absorbs Howard-Payne Junior College as part of a reorganization and consolidation effort by the Methodist Episcopal Church South. Central College soon also acquires the assets of the Central College for Women, Lexington; Scarritt-Morrisville College, Morrisville; and Marvin College, Fredericktown. (Central Methodist University, MO)
- Fargo College closes due to increasing expenses that cannot be covered by student fees, and insufficient endowment. Its assets are merged into Yankton College, SD. (Closed, ND)

- The Daytona-Cookman Collegiate Institute is created by merging the Daytona Normal and Industrial Institute and the Cookman Institute. (Bethune-Cookman University, FL)
- o The Baltimore College of Dental Surgery merges with the Dental Department of the University of Maryland to create a distinct college of the university under state

- supervision. (University of Maryland, Baltimore. MD)
- o Intermountain Union College is found by merging Montana Wesleyan College with the organization of the College of Montana. (Rocky Mountain College, MT)

- Harding College, a 4-year college with elementary and secondary programs is created by the Churches of Christ by merging Harper College and Arkansas Christian College, (Harding College, AR)
- The Kirksville Osteopathic College, founded by merging the American School of Osteopathy and the Andrew Taylor Still College of Osteopathy. (the Kirksville campus of AT Still University. MO).
- O Cincinnati Bible Seminary, founded by merging McGarvey Bible College and the Cincinnati Bible Institute. Both were founded by conservative theological faculty following the "heresy trials" at the College of the Bible in Lexington, KY revolving around the practices of faculty using new approaches to Bible scholarship. (Cincinnati Christian University, OH)

1925

- o Indiana Dental College is acquired by Indiana University. (IN)
- o Campion College of the Sacred Heart closes because of lack of space. The high school division is much larger and continues. (WI)

1926

- The Chicago Theological Seminary absorbs the Congregational Training School for Women. (IL)
- The Lindlahr College of Natural Therapeutics is merged into the National College of Chiropractic, which then offers a degree program in naturopathy until 1952. (National University of Health Sciences, IL)
- o Kentucky College for Women becomes Centre College's "women's department." They become fully merged in the 1960s. (Centre College, KY)
- Winfield College of Music merges into Southwestern College. (KS)
- o The Julliard School of Music, founded by merging the Juilliard Graduate School and the Institute of Musical Art. (NY)
- University of Dallas faces financial problems, so closes its Collegiate Division, boarding school, and athletic programs. The academy closes in 1928. The charter is then maintained by the Catholic Diocese of Dallas, who eventually transfer it to the Sisters of St. Mary of Namur, who open the present University of Dallas. (TX)

- Western Kentucky State Normal School and Teachers College merges with Ogden College. (Western Kentucky University, KY)
- o The New Jersey College of Pharmacy merges into Rutgers University. (NJ)
- o Erskine College, Due West Woman's College, and Erskine Theological Seminary merge under the name of Erskine College. (SC)
- Des Moines University is sold to the Baptist Bible Union due to financial difficulties.
 The extreme fundamentalism of the Baptist Bible Union leads many faculty to leave and in 1929, the students to riot against the trustees and administration. The University closes and its assets are acquired by Sioux Falls University. (SD)
- Hall-Moody Junior College faces declining enrollments and financial difficulty, so the Tennessee Baptist Convention closes it and merges its assets into Union University. (TN)

- Financial difficulties leads St. Stephen's College to merge into Columbia University as an undergraduate college. It becomes fully secular and becomes the first college in the U.S. to give full academic status to the study of the creative and performing arts. (Bard College, NY)
- Oxford College for Women is merged into Miami University. (OH)
- o Schuylkill College merges into Albright College. (PA)
- The Hebrew Education Society merges into Gratz College. The merger is made possible by a special grant voted by the Federation of Jewish Charities. (PA)

1929 The Stock Market Crash of 1929, beginning the Great Depression, 1929-33

- The Boston School of Physical Education faces dire financial challenges, and merges with the Bouvé School from which it had split some years earlier. The new school is named the Bouvé-Boston School of Physical Education. (Northeastern University, MA)
- Hannibal-LaGrange College is founded through the merger of Hannibal College and LaGrange Male and Female Seminary. (Hannibal-LaGrange University, MO)
- The Bethel Bible Training Institute of Newark, N.J. merges into Central Bible Institute,
 MO. (Evangel University, MO)
- o Eureka College closes due to lack of enrollment. (NC)
- o Bethany-Peniel College absorbs Central Nazarene College. (Southern Nazarene University, OK)
- Bryson College closes and merges into Erskine College. There are reports that Bryson's negotiations to become a state-supported institution hurt the Presbyterian college's enrollment. (SC)
- Sioux Falls University acquires 4 defunct Baptist schools in quick succession: Des Moines University (IA), Cedar Valley Seminary, and Parker College (MN), and Grand Island College. With the final merger of Grand Island College in 1931, the institution is renamed Sioux Falls College. (University of Sioux Falls, SD)

- O Lombard College closes because of decreases in the endowment, deficit financing, the failure of the Universalist and Unitarian churches, and the stock market crash. Students and alumni are invited to join Knox College and its Alumni Association. Its Divinity School merges with Meadville Theological School, and the resulting Meadville Theological Seminary in Chicago continues to hold the Lombard charter. (IL)
- Teachers College of Indianapolis merges into Butler University, establishing its College of Education. (Butler University, IN)
- Missouri Wesleyan College becomes a 2-year college because it has lost its accreditation and closes in 1930. Its assets go to Baker University. (KS)
- Mount Ida School for Girls closes down due to financial difficulties during the Depression and is purchased and reopened in 1939 as Mount Ida Junior College, a women's school, that does not confer associate's degrees until 1967. (Mount Ida College, Closed, MA)
- The Pittsburgh-Xenia Theological Seminary of the United Presbyterian Church is founded by merging the Xenia Theological Seminary and the Seminary of the Associate Reformed Presbyterian Church. (Pittsburgh Theological Seminary, PA)
- Queens College becomes associated with the Presbyterian Synod of South Carolina through a merger with Chicora College in SC. (Queens University of Charlotte, NC)
- Summerland College merges with Newberry College, making the latter coeducational.
 (SC)

o Texas Presbyterian College merges into Austin College. (TX)

1931

- O University of Hawaii absorbs the Territorial Normal and Training School, which is renamed Teachers College. (University of Hawaii, HI)
- Bethany-Peniel College absorbs Arkansas Holiness College. (Southern Nazarene University, OK)
- Decause of enrollment and financial problems the Methodist Church trustees vote to close Texas Women's College. It is saved by merging with Texas Wesleyan Academy in 1935. (Texas Wesleyan University, TX)
- Martha Washington College closes and its business becomes a hotel. (Emory and Henry College, VA)

1932

- Mount Morris College is destroyed by fire in 1931, and merges into Manchester College in 1932. (Manchester University, IN)
- New Orleans Conservatory of Music and Dramatic Art merges into Loyola University.
 (Loyola University New Orleans, LA)
- The Portland School of Social Work and the University of Oregon nursing program are taken over by the Oregon Medical School to form its Department of Nursing Education. (Oregon Health and Science University, OR)
- The Philadelphia School of Design for Women merges into the Moore Institute of Art, Science, and Industry. (Moore College of Art and Design, PA)
- Alderson Broaddus College is created by merging Alderson Academy and Junior College and Broaddus College. (Alderson Broaddus University, WV)
- o Hartshorn Memorial College merges into Virginia Union University. (VA)

1933

- Wartburg College merges with Wartburg Normal College. (Wartburg College, IA)
- The Colleges of the City of Detroit is founded by merging the Detroit Medical College, the Detroit Teachers College, and the Detroit College of Pharmacy. (Wayne State University, MI)

1934

- The Evanston Collegiate Institute is created by merging the Swedish Methodist Theological Seminary and the Norwegian-Danish Theological Seminary. (Kendall College, IL)
- The Chicago Training School merges into Garret Biblical Institute. (Garrett-Evangelical Theological Institute, IL)
- Brevard College, founded by merging Rutherford College, Weaver College, and Brevard Institute under the control of the Western North Carolina Conference of the Methodist Episcopal Church, South. (NC)
- Northwest Christian College is created by merging Spokane University assets into Eugene Bible College after the former fails financially. (Northwest Christian University, OR)
- o The San Antonio School of Law merges into Saint Mary's University. (TX)

- o Saint Paul-Luther College merges into Wartburg College. (IA)
- O Dillard University is founded as a result of merging New Orleans University and Straight College. It is planned as a coeducational, interracial school with a

- predominantly African American student body. (LA)
- Texas Wesleyan College is created by merging Texas Women's College and Texas Wesleyan Academy. (Texas Wesleyan University, TX)

- The Benjamin Harrison Law School merges into the Indiana Law School. (Indiana University Purdue University Indianapolis, IN)
- Marian College is created by merging St. Francis Normal School for Women and Immaculate Conception Junior College. (Marian University, IN)
- The University of Newark is created by merging together Dana College, New Jersey Law School, and the Seth Boyden School of Business. (Rutgers, The State University of New Jersey-Newark, NJ)
- The Rochester Athenaeum and Mechanics Institute acquires the Empire State School of Printing, which has faced declining enrollment because of the Depression. (Rochester Institute of Technology, NY)

1937 Recession of 1937-38

1938

- Kansas City School of Law merges into University of Kansas City (University of Missouri-Kansas City, MO)
- Millaps College absorbs Grenada College and Whitworth Female College, both of which are facing severe financial challenges. (MS)
- New York Medical College, Flower and Fifth Avenue Hospitals is created by merging New York Medical College and Flower. It is chartered to offer doctoral degrees as well as medical degrees. (New York Medical College, NY)
- Washington Bible Institute, based in MD, founded by merging the Bible Institute of Washington, emphasizing outreach to Jews; The American Home Bible Institute, emphasizing correspondence courses and home study; and the Washington School of the Bible, emphasizing Bible training for full-time Christian workers. (Lancaster Bible College, PA)
- o Greenville Woman's College merges into Furman University, (Furman University, SC)

1939

- Mississippi Synodical College is merged into Belhaven College. (Belhaven University, MS)
- Eastern Bible Institute is founded by the consolidation of Beulah Heights Bible and Missionary Training School (NJ), Metropolitan Bible Institute (NY), New England Bible Institute (MA), and Pine Crest Bible Institute (NY). (University of Valley Forge, PA)
- Richmond Professional Institute of the College of William & Mary is created by merging together the Richmond School of Social Economy, the Richmond School of Art, and the School of Store Services Education plus other vocational departments.. (Virginia Commonwealth University, VA)

- The Illinois Institute of Technology is created by merging the Armour Institute of Technology and the Lewis Institute. (IL)
- Bethany-Peniel College absorbs Bresee Theological College. (Southern Nazarene University, OK)

- 1941 The U.S. enters World War II, 1941-45
 - The Kansas City-Western Dental College merges into the University of Kansas City.
 (University of Missouri-Kansas City, MO)

- The Florida Baptist General State Convention merges the Florida Baptist Institute and the Florida Normal and Industrial Institute, which changes from a junior college to a 4-year liberal arts institution. (Florida Memorial University).
- 1943 The V-12 Navy College Training Program launched at 131 colleges and universities
 - University of Connecticut acquires the Hartford Colleges of Law and Insurance.
 (University of Connecticut)
 - Western University closes after years of decreased state funding, other financial challenges, and lack of enrollment. Its programs are absorbed into the Kansas State Industrial School. (KS)
 - Asheville Farm School and the Dorland-Bell School for girls merge to become a coeducational secondary school, the Warren H. Wilson Vocational Junior College and Associated Schools. (Warren Wilson College, NC)
 - The State Teachers College at Radford and the Virginia Agricultural and Mechanical College and Polytechnic Institute merge as an effort to consolidate higher education institutions. Radford becomes the Women's Division of V.P.I. (Virginia Polytechnic Institute and State University, Radford University, VA)

1944 The GI Bill

- Weatherford College faces declining enrollment ad financial problems and merges into Southwestern University. (TX)
- o Westminster College is merged into Southwestern University. (TX)

- The King's College (Briarcliff, NY), facing declining enrollments, a financial crisis, and loss of accreditation, declares bankruptcy and closes. Its charter is acquired by the Campus Crusade for Christ, International. (NY)

- o Jordan College faces charges of fraud, has been facing litigation regarding mismanagement of federal student aid, and closes. (MI)
- Upsala College's accreditation is about to be reject for renewal of its accreditation because of declining academic standards and \$12.5 million in debt, so it declares bankruptcy and closes.
- The Wisconsin Synod closes Northwestern College and merges it into Martin Luther College. (MN)
- Kenrick-Glennon Seminary is created by merging Kenrick Seminary and Cardinal Glennon College. (MO)

- o Because of financial difficulties faced by Westbrook College, it merges with the University of New England, but under the charter of Westbrook. (ME)
- The Kendall College of Art and Design and Ferris State University begin a 4-year process of merging the former into the latter. (MI)
- o Rogers University is created by merging Rogers State College and the University Center at Tulsa (UCAT). (Rogers State University, OK)
- George Fox University is created by merging Western Evangelical Seminary into George Fox College. (OR)
- o Allegheny University of the Health Sciences is founded when the Allegheny Health, Education, and Research Foundation acquires both MCP and Hahnemann University and their hospitals and merges them. (Drexel University, PA)

Union-PSCE is founded by merging the Presbyterian School of Christian Education and the Union Seminary. (Presbyterian Union Seminary, VA)

- o After years of falling enrollments, St. Meinrad College closes. (IN)
- o Saint Francis College acquires the Lutheran College of Health Professions and is renamed the University of Saint Francis. (IN)
- o The Art Institute of Boston merges into Lesley College. (Lesley University, MA)
- o Phillips University files for bankruptcy and closes. (OK)

1999

 Northwestern Health Sciences University is created by merging Northwestern College of Chiropractic and the Minnesota Institute of Acupuncture and Herbal Studies. (MN)

2000

- The University of Arkansas- Fort Smith is created by merging Westark College into the University of Arkansas. (AK)
- o George Williams College merges into Aurora University. (IL)
- o Davenport University is created through a merger of Davenport College, Detroit College of Business, and Great Lakes College. (MI)
- O Global University is founded when the Assemblies of God merges Berea University and ICI University. (MO)
- o The Dickinson School of Law merges into Pennsylvania State University. (PA)
- Chatanooga Bible Institute merges into the Psychological Studies Institute. (Richmont Graduate University, TN)
- o Trinity College closes because of financial problems. Its graduate programs move to the Vermont Center of Southern New Hampshire University in Colchester. (VT)

- o Alliant International University is created by merging United States International University with the California School of Professional Psychology. (CA)
- o Notre Dame College closes due to financial and enrollment challenges. (NH)
- The College of Insurance closes and St. John's University takes over its programs.
 (NY)
- Oregon Health and Science University is created by merging Oregon Health Sciences University with the Oregon Graduate Institute. (OR)
- The Montpelier campus of Norwich University (formerly Vermont College) is acquired by the Union Institute. (Vermont College of Fine Arts, VT)

- Marymount College is consolidated into Fordham University and eventually phased out. (NY)
- MCP Hahnemann University merges into Drexel University to become its College of Medicine, College of Nursing and Health Professions, and Dornsife School of Public Health. (PA)
- o Mount Senario College closes after years of financial trouble, enrollment loss and threats of accreditation loss. (Closed, WI)

2004

 Resurrection Health Care purchases the West Suburban Medical Center and the College of Nursing. (Resurrection University College of Nursing & College of Allied Health, IL)

- William Tyndale College closes after years of financial challenges, many attempts to assist it, including by public officials and by Regent University, and finally, a successful federal lawsuit alleging that school officials were improperly using federal student aid funds. (Closed, MI)
- o Potomac State College is merged into West Virginia University. (WV)

o The Medical University of Ohio merges into the University of Toledo. (OH)

2007 The Great Recession, 2007-09

- The American Jewish University is founded by merging the University of Judaism and the Brandeis-Bardin Institute. (CA)
- Georgia Aviation Technical College (Eastman) is merged into Middle Georgia
 College. (Middle Georgia State University, GA)
- West Virginia Institute of Technology merges into West Virginia University. (WV)

2008

- Weston Jesuit School of Theology merges into Boston College, and is renamed the Boston College School of Theology and Ministry. (Boston College, MA)
- Polytechnic University merges into New York University and becomes the Polytechnic Institute of New York University, eventually its School of Engineering. (NY)

o Jesuit School of Theology of Santa Clara merges into the Santa Clara University, becoming the Jesuit School of Theology of Santa Clara University. (CA)

2010 Maryland is the first state to recognize and govern a new corporate form, the public benefit corporation, increasingly used by for-profit higher education institutions to make them treated as nonprofit institutions.

- Lincoln College of New England is founded by merging Briarwood College with Clemens College. (CT)
- The Michigan Theological Seminary merges with Moody Theological Seminary to become Moody Theological Seminary Michigan. (MI)

- O Dana College, facing a financial crisis, seeks to sell itself to the Dana Education Corporation, a new corporation owned by Nebraska Higher Education Holdings, LLC., who will turn it into a for-profit institution. Its regional accreditation agency denies the change of control for many reasons, including a lack of apparent financial sustainability and the inexperience of the proposed ownership and leadership in liberal arts education, the business of the College. It closes. Midland University acquires the property but decides not to reopen the college. (NE)
- College of Eastern Utah merges with Utah State University, making the former Utah State University Eastern. (UT)
- 2011 In reaction to findings of problematic business practices of for-profit institutions, the Obama Administration releases "Program Integrity: Gainful Employment Measures," new regulations that especially affect for-profit institutions that could make many of them ineligible for federal financial aid.
 - The Florida Center for Theological Studies merges into the School of Theology and Ministry at St. Thomas University. (FL)
- 2012 Public Release of <u>For Profit Higher Education: The Failure to Safeguard the Federal Investment and Ensue Student Success ("The Harkin Report"</u>). Many for-profit institutions begin to go out of business as they are held to more scrutiny.
 - o Georgia Regents University is created by merging Augusta State University and Georgia Health Sciences University. (Augusta University, GA)
 - Middle Georgia State College is created by merging Macon State College and Middle Georgia College. (Middle George State University, GA)
 - Chester College of New England closes due to numerous problems, including a faculty vote of no confidence in the president. Most of the students transfer to the New Hampshire Institute of Art. (NH)
 - Lutheran Theological Southern Seminary of Columbia, SC merges into Lenoir-Rhyne University. (NC)
 - The University of Medicine and Dentistry of New Jersey is dissolved. Most of its schools merge with Rutgers University to form a new Rutgers School of Biomedical and Health Sciences. The School of Osteopathic Medicine and its Graduate School of Biomedical Sciences merge with Rowan University. (NJ)
 - o Ohio College of Podiatric Medicine is acquired by Kent State University. (OH)
 - Mountain State University loses its regional accreditation because of academic, financial, and leadership problems. It closes, and the University of Charleston takes over the assets. The assets were acquired again later by the West Virginia University Institute of Technology. (Closed, WV)
 - o Concordia University in Wisconsin merges with Concordia University in Ann Arbor because of the drop in enrollment at the latter campus. (Concordia University, WI)

- Washington Theological Union closes after 2 years of a step-down process due to financial troubles. (DC)
- University of North Georgia is created by merging North Georgia College and State University and Gainesville State College. (GA)
- South Georgia State College is created by merging South Georgia College with Waycross College. (GA)
- Bangor Theological Seminary closes as a result of the decline need for ministers of mainline churches such as the United Church of Christ, with which the Seminary is associated. It has been spending its endowment principal for operations. (ME)

- o College of Visual Arts closes due to severe financial challenges. (Closed, MN)
- The Assemblies of God merge Central Bible College and Assemblies of God Theological Seminary into Evangel University. (MO)
- Lancaster Bible College acquires the academic programs of Washington Bible College/Capital Bible Seminary. (PA)
- o Florida Christian College (FL) merges into Johnson University (TN) and becomes Johnson University Florida.

- The Thunderbird School of Global Management merges into Arizona State University (AZ)
- o The Lyme Academy of Fine Arts is merged into the University of New Haven. (CT)
- o Lexington College in Chicago has fewer than 100 students and closes. (IL)
- The New England School of Communications is merged into Husson University.
 (ME)
- o Calvary Baptist Theological Seminary closes due to financial problems. (PA)

- Clearwater Christian College because of financial problems and declining enrollments.
 (FL)
- Marion Court College closes because of financial problems and declining enrollments.
 (MA)
- William Carey College closes because enrollment does not rebound after Hurricane Katrina. (MS)
- The Forest Institute of Professional Psychology closes due to financial problems.

- o St. Catharine College closes because of massive debt. (KY)
- The George Meany Center for Labor Studies the National Labor College closes due to financial problems. (MD)
- o The School of the Museum of Fine Arts is merged into Tufts University. (MA)
- The Boston Conservatory merges into the Berklee College of Music, becoming Boston Conservatory at Berklee. (MA)
- Roger B. Miller College closes due to a history of financial improprieties and its unsustainable deficit. (MI)
- Daniel Webster College, a private, nonprofit college until ITT bought it and turned it into a for-profit institution in 2009, now closes because ITT has gone bankrupt.
 Southern New Hampshire University agrees to do teach-out programs for its students for one year. (NH)
- Union Graduate College merges into Clarkson University to become the Clarkson University Capital Region Campus. (NY)
- o Burlington College closes because of significant financial problems. (VT)

- Colorado Heights University, operated by the multinational foundation Teikyo University Group, closes. (CO)
- o Armstrong State University merges into Georgia Southern University. (GA)
- o Abraham Baldwin Agricultural College merges into Bainbridge State College. (GA
- o St. Joseph's College, facing a \$27 million debt, closes. Marion University plans to

- reopen the institution as a 2-year campus of Marion University. (IN)
- Boston University acquires financially troubled Wheelock College, which ceases to operate as an independent institution and becomes a college of Boston University.

- o St. Gregory's University, having faced earthquake damage and financial crises, goes bankrupt and closes. (OK)

- Lincoln College of New England is put on probation by its regional accreditation agency and closes. (CT)

- o Belmont University acquires the O'More School of Design. (TN)
- Northern Vermont University is founded by merging Johnson State College and Lyndon State College, with two campuses called NVU-Lyndon and NVU-Johnson. (VT)

2019

- o Newbury College closes due to financial challenges. (MA)
- Baker College announces plans to close a few of its campuses in a consolidation move. (MI)
- The College of New Rochelle closes after years of financial challenges, including admission of faked budgets. (NY)
- Oregon College of Art and Craft closes after failed attempts to merge with another institution. (OR)
- o Green Mountain College closes due to financial problems. (VT)
- The School for International Training Graduate School, facing loss of enrollment, closes its VT education programs, operating them only on other sites. (VT)
- Southern Vermont College loses its accreditation because of financial instability and closes. (VT)
- o Jefferson College of Health Sciences announces it will merge into Radford University by the end of 2019. (VA)
